## INVESTMENT OBJECTIVE

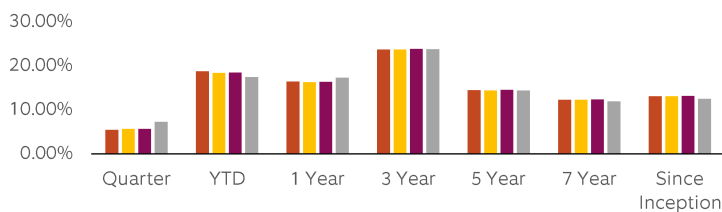
