INVESTMENT OBJECTIVE

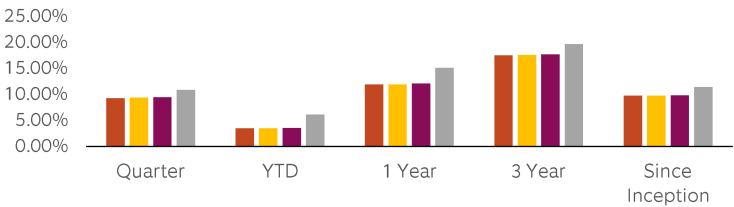

INVESTMENT APPROACH

The Northern Trust ESG & Climate US Large Cap Core Index is designed to construct a universe of large capitalization, companies that possess environmental, social, and governance (ESG) characteristics.
