## INVESTMENT OBJECTIVE

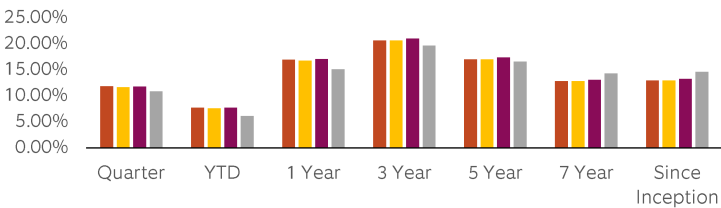
